# **Rules and Regulations**

**SCHEDULES:** All Schedules are tentative and subject to change. Updated schedules and daily schedules are available at <a href="https://www.tryon.com">www.tryon.com</a>.

**ENTRIES:** Entries must be made online. All horses on property must be entered and have an assigned back number. Entries must include:

- All classes or divisions entered
- All mandatory signatures, including legal guardian in the case of a minor exhibiting
- Social Security or Federal ID number of person receiving prize money

### **CLOSING DATES for entries are as follows:**

Tryon Indoor Winter 1- January 16, 2022

Tryon Indoor Winter 2- January 23, 2022

Tryon Indoor Winter 3- January 30, 2022

Tryon Indoor Winter 4- February 6, 2022

After the closing date stall fees are non-refundable. Scratches after the closing date will incur a \$15 Scratch Fee. Entries should be submitted via our online entry system at www.tryon.com or www.showgroundslive.com. EMAILED/SCANNED/FAXED ENTRIES WILL NOT BE ACCEPTED. Back numbers will not be issued without a signed open check drawn on a US bank or credit card information lodged with the Horse Show Secretary. A \$30 fee will be charged for non-negotiable checks or credit cards declined for any reason. All accounts must be closed out by Sunday of each show week unless prior arrangements have been made with the horse show secretary.

**Add Back Classes:** Add Back classes will be paid back \$15 per entry, divided by the top 4, as follows: 40%, 30%, 20%, 10%.

**NON-SHOWING HORSES:** All non-showing horses must have an entry blank on file in the office and will be assigned a number. A \$25 Non-Showing Fee will be assessed to any horse not entered in any classes.

# STALLS: Stalls are limited and will be sold on a first-come, first-serve basis.

All stalls are non-transferable and remain under the ownership and control of Tryon International Equestrian Center. Permanent 10x12 stalls of wood/metal construction. Stalls are available at \$150 per stall. Stalls are not refundable after the closing date. To ensure stabling as well as your initial bedding/feed orders, please complete an online entry at Tryon.com. Non-stabled horses will pay a \$35 Ship-In Fee. Stalls are available for move in at 8AM each Wednesday.

**Attire:** Jackets will be worn for the hunter and equitation classes in the show rings. Riders will be allowed to show in tucked-in polo shirts in the jumper rings. The hunter derby and mini-prix require formal attire.

Lunging: No lunging permitted in the show rings. Lunging only in designated areas.

**Schooling:** Schooling in the show rings without permission is prohibited at all times. \$100 fine for anyone caught in the rings before or after the show if rings have been closed. Management may restrict schooling in any ring if conditions warrant.

**TRAINER SPLITS**: Trainer Splits are done as a courtesy and must be turned into the Horse Show Office by 12:00 noon on Saturday. Any trainer accounts which have not been split, for any reason, will be evenly split on all horses entered into the horse show.

**PROTECTIVE HEADGEAR:** Protective headgear, properly secured, must be worn BY ALL RIDERS AT ALL TIMES WHEN MOUNTED, anywhere, anytime on the horse show grounds. Headgear for all riders must meet or exceed ASTM Standards: must carry the SEI tag; and be properly secured by a harness.

# **Rules and Regulations**

MINORS/MINOR EXHIBITORS: Parent(s) or guardian(s) of minors/minor exhibitors shall hold the Horse Show Management and the Facility harmless for any injury to such minor. No child's entry will be accepted or number issued unless the entry is signed by a parent or LEGAL guardian. The signature of unrelated persons WILL NOT be accepted. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions.

**DOGS:** Dogs are not permitted to be loose on competition grounds and must be held on a leash or otherwise contained at all times. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. Failure to maintain your dog under control, as defined here, will result in a \$100 fine assessed to the owner. In addition, pursuant to facility regulations, loose dogs will be removed from the show grounds by Animal Control, at the owner's expense and impounded.

**PARKING:** Fire regulations prohibit all vehicles, including trailers, vans and passenger vehicles from being parked in the stable areas. Vans and trailers will be allowed in the stable area only to load or off-load. PARKING AREAS WILL BE DESIGNATED AND VIOLATORS WILL BE TOWED AWAY AT OWNER'S EXPENSE.

ANIMAL WELFARE: We require that all horses be treated with kindness, respect and compassion and should never be subject to mistreatment. Owners, trainers, riders and grooms, or their agents must use reasonable care in the handling and treatment of their horses whether owned or placed in their care for competition or for any other purpose. No poling, use of bamboo off-set or excessive use of the whip will be tolerated. The well-being of the horse must be considered above the demands of the breeders, trainers, riders, owners, dealers, organizers, sponsors or officials. IN THE EVENT OF AN ACUTE AND SERIOUS INJURY TO OR ILLNESS OF A HORSE ON COMPETITION GROUNDS WHEN THE OWNER OR TRAINER OF THE HORSE OR AGENT OF THE OWNER IS NOT PRESENT, AFTER REASONABLE EFFORT TO CONTACT THAT INDIVIDUAL HAS BEEN MADE, COMPETITION MANAGEMENT, IN CONSULTATION WITH A LICENSED EQUINE VETERINARIAN, MAY AUTHORIZE THE PROVISION OF EMERGENCE VETERINARY TREATMENT OF THE HORSE. IF COMPETITION MANAGEMENT SO AUTHORIZES TREATMENT UNDER THE PROVISIONS OF THIS RULE, COMPETITION MANAGEMENT AND VETERINARIAN ARE NOT LIABLE FOR ANY RESULTING COSTS, DAMAGES, LOSSES, CLAIM OR ACTIONS ARISING DIRECTLY OR INDIRECTLY FROM THE TREATMENT OF THE HORSE.

**ELECTRICAL/FIRE REGULATIONS:** All electrical installation and connections must meet all state and county codes. Aisles will be maintained clear for a minimum of six (6) feet wide by eight (8) feet high. No obstructions or projections shall be allowed in the aisles. No Class 1 Flammable liquids such as gasoline are allowed inside the buildings. Cooking is not permitted within the stable area. Anyone found in violation shall be subject to dismissal from further participation in the horse show without recourse.

**MOTORIZED VEHICLES/GOLF CARTS:** Under North Carolina State Laws, unlicensed drivers are not permitted to operate any motorized vehicles - ATV's, motorcycles, golf carts, etc., on the show grounds. Failure to abide by these regulations will subject the exhibitor to suspension from the horse show.

**LIABILITY:** Tryon Horse Shows, LLC, Tryon International Equestrian Center, their officials, and employees will not be responsible for any accident or loss which may occur to any exhibitor, spectators, guest, rider, groom, attendant, other employees, animals, or equipment at the events. All owners and competitors are personally responsible for damages to third persons caused by themselves, their employees, their agents, their horses, or their dogs. They are therefore strongly advised to take out third party insurance providing full coverage for participation in equestrian events, and to keep that policy up to date.

- 2. Submit an entry with a stall fee added and paid for
- 3. If you are shipping your horse in for the weekend, add the "Ship In Fee" when entering
- 4. Tack stalls can be ordered directly onto horses or onto the barn account (which is automatically created) and can be split when you check in for the show

#### Cost

- 1. \$150 per stall, this fee includes Equine Night Security
- 2. Full payment is required for a stall to be considered reserved

#### **Deadline**

- 1. Stalls are non-refundable after the closing date of each show
- 2. Stalls are limited and will be available on a first come first served basis

#### **Cancellations**

- 1. Stalls cancelled after the closing date are non-refundable

# Release, Assumption of Risk, Waiver, and Indemnification This Document waives important legal rights. Read it carefully before signing.

I **AGREE** in consideration for my participation, attendance, and/or stabling at the Tryon International Equestrian Center (TIEC), to the following:

I **AGREE** that the TIEC and "participation" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations. I **AGREE** that I choose to participate voluntarily in events at TIEC with my horse, or as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior participant. I am fully aware and acknowledge that horse sports and these events involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death. ("Harm")

I **AGREE** to hold harmless and release the TIEC from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the TIEC.

I **AGREE** to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the TIEC. I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any equestrian activity involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases),trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

# **EQUINE ACTIVITY LIABILITY ACT WARNING:**
